2. Bidders should submit two (2) copies, one marked "original" and others marked "copy"

A Complete set of Pre-qualification documents in English may be obtained from Procurement and Disposal Unit office upon Payment of a non-refundable fee shall be **UGX. 70,000/= per item in all the LOTS of Supplies and Services** to Kyegegwa Rural Electricity Cooperative Society Savings Account Number: **5620400804, Centenary Bank (Mubende Branch) or Cashier at KRECS Offices.**
4. Interested bidders are also invited to inspect the bid document on Krecs website (www.krecsltd.org) to obtain full details after which you will pay a non-refundable fee in the bank or to Cashier at KRECS Office and obtain a General Receipt which you will present to the Procurement and Disposal Unit and be given a bid document.

5. Applicants should attach copies of the following documents where applicable:

- a) Name and address of the business or individual (Postal address including telephone Numbers and other contact details);
 - b) Business/personal bank account;
 - c) Proof of physical location of business premises e.g. street, plot number, house name
 - d) List of owners and directors of the firm/business or individual;
 - e) Current Trading License;
 - f) Certificate of Registration or incorporation for registered firms only;
 - g) Memorandum and Articles of Association for registered firms only;
 - h) Registration certificates for value added tax (VAT) for Value added taxable items and persons; **OR** E-tax numbers where applicable
 - i) Prepare and Attach Price Lists for supplies.
 - j) Copy of income tax clearance certificate addressed to Kyegegwa Rural Electricity Cooperative Society ;
 - k) Company or Business profile with details of all staff, equipment, tools, machinery in line with what is applied for.
 - l) Proof of contracts executed e.g. Certificates of completion for at least the last two financial years etc.
 - m) Financial status of the firm/company/individual (Bank statement);
 - n) A recommendation letter from Local Council I and Sub County Authority for individuals only
